Dr. Richard Izquierdo Charter Schools ("we", "us", or "our") knows that you care about how your personal information is used and shared. We take your privacy seriously and want to outline the measures we take in safeguarding your personal information, the choices available to you regarding our use of your personal information and how you can access and update this information. IP Addresses, Cookies & Other Technology
